Business & Professions Code section 6450, et.seq., which took effect January 1, 2001, requires that paralegals obtain four hours of continuing education every two years in legal ethics and four hours every three years in general law or a specialized area of the law.

#### **Business & Professions Code section 6450(d):**

All paralegals shall be required to certify completion every three years of four hours of mandatory continuing legal education in legal ethics. All continuing education courses shall meet the requirements of Section 6070. Every two years, all paralegals shall be required to certify completion of four hours of mandatory continuing education in either general law or in a specialized area of law.
