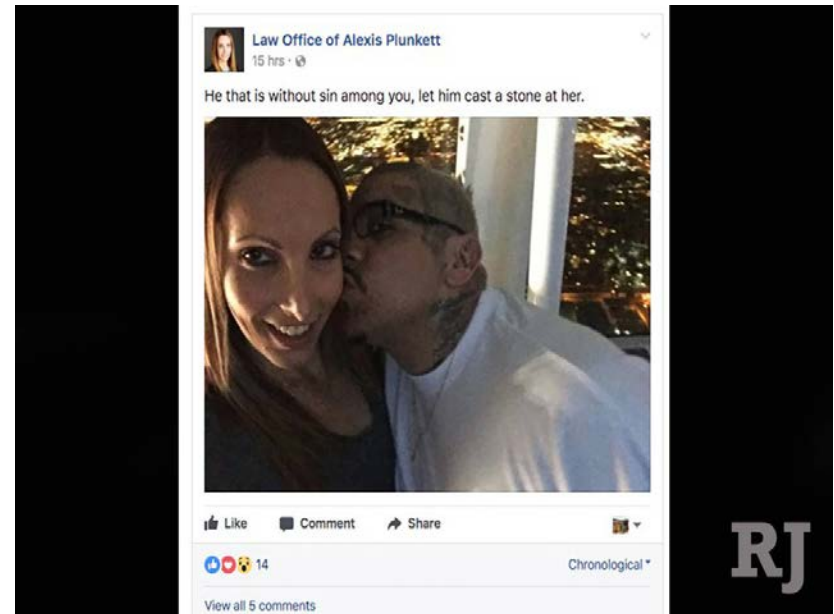
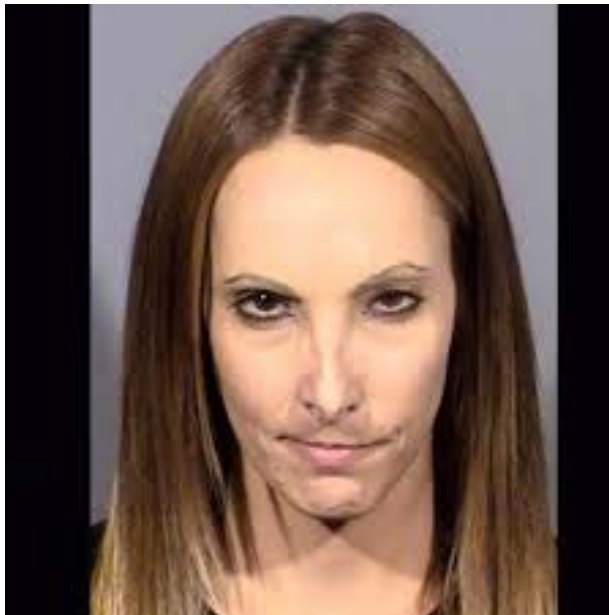

- “State Bar of Nevada wants to disbar lawyer charged with stealing millions from clients” – LVRJ



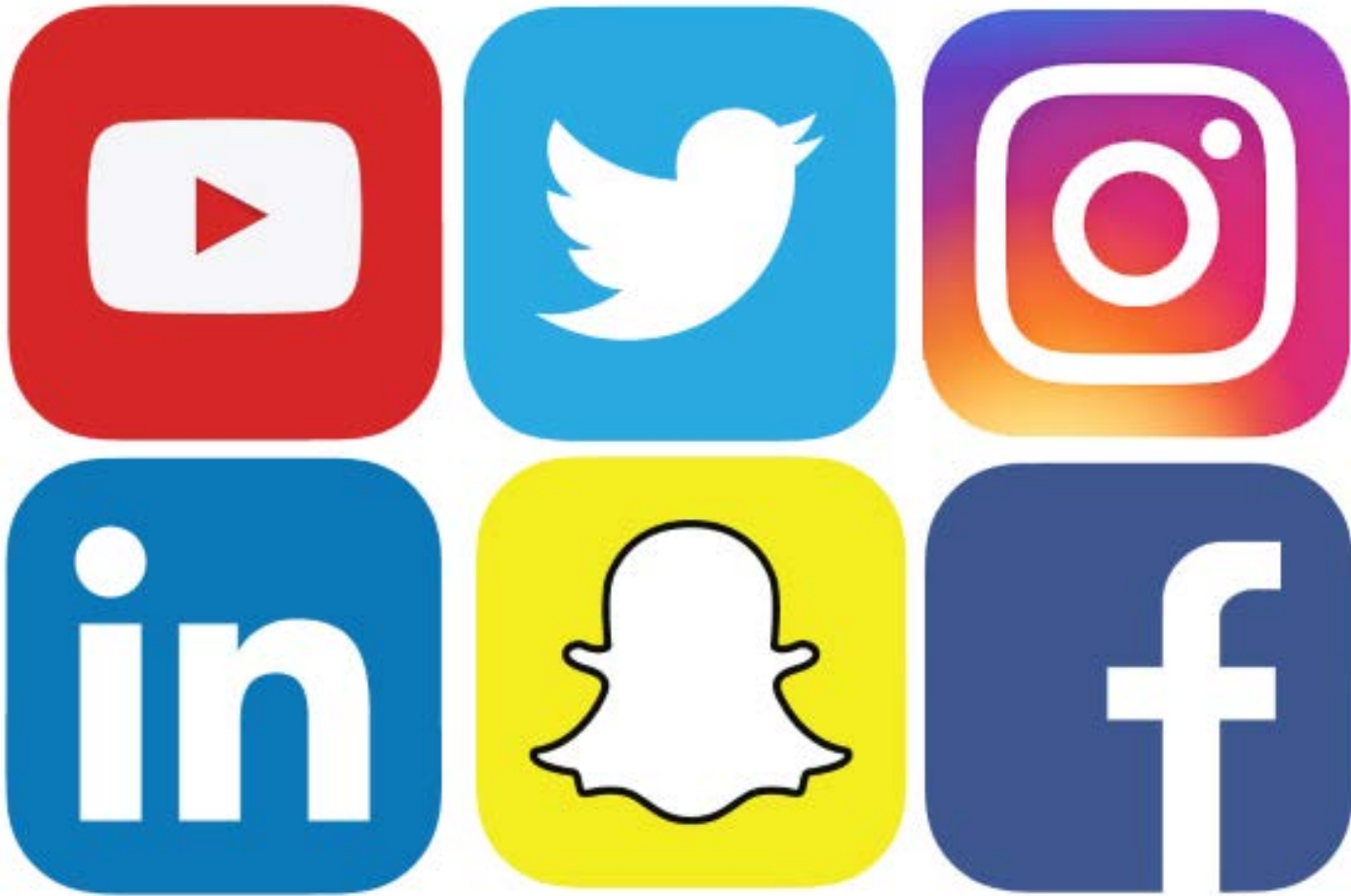

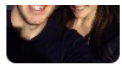
